

Green Living “Are You Smarter than our Expert?” Sweepstakes RULES

No purchase is necessary. Each associate is eligible to enter for a chance to win beginning June 20, 2017 through July 5, 2017 (the “Sweepstakes Period”) by taking an eight-question “quiz” on *macysgreenliving.com*. The Sweepstakes will be featured on MyMacy’s portal and My IN-SITE for Macy’s store and support associates, as well as in Bloomingdale’s store and central communication.

The Sweepstakes details are as follows:

All associates who take the full quiz on *macysgreenliving.com* during the Sweepstakes period and accurately answer all eight questions will be entered for a chance to win a prize package in a random drawing. A total of five (5) winners will be selected in this Sweepstakes. Sponsor’s computer system will be the official timekeeper for the Sweepstakes.

There will be a total of five (5) Sweepstakes prizes awarded, each a prize package of four items listed below. See Official Rules for complete description.
